DUE TO NON-AVAILABILITY OF SUITABLE OFFICERS FOR POSTING AS DIRECTOR (CENSUS OPERATIONS) IN THIS STATE, IT HAS BEEN DECIDED THAT THE POST OF DIRECTOR (CENSUS OPERATIONS), KERALA CAN ALSO BE FILLED UP BY IAS OFFICERS BORNE ON OTHER CADRES AS IN THE CASE OF OTHER STATES i.e. ASSAM, ANDHRA PRADESH, ARUNACHAL PRADESH, BIHAR, DELHI, JAMMU & KASHMIR, JHARKHAND, MANIPUR, MEGHALAYA, ORISSA, RAJASTHAN, SIKKIM, TAMIL NADU, AND UTTARAKHAND FOR WHICH THE STATE GOVERNMENTS WERE EARLIER REQUESTED TO SPONSOR NAMES. 3. THE DUTIES ASSIGNED TO THE POST OF DIRECTOR CENSUS OPERATION INCLUDE EFFECTIVE SUPERVISION, COORDINATION AND LIASIONING WITH DISTRICT COLLECTORS, FOR THE WORK OF CENSUS TAKING -2011 (.)
