- (x) The officer should have cumulative work experience of at least 2 years in the Ministry of Commerce, Industry, Textiles, Communications and IT of the GOI or in the State Government.

#### B. Desirable Qualifications:-

- Experience in Bilateral/ International negotiations.
- Exposure to International Trade.
- Officers having work experience in dealing with European Union / European Commission.
- 3. This post may be circulated amongst officers eligible to be appointed at the level of Deputy Secretary / Director in the Government of India on priority basis. Names of willing and eligible officers who can be spared by the State Governments/Ministries/Departments may be forwarded/faxed to this Department along with Cadre clearance, Vigilance clearance, detailed Bio-data and certified ACR grading of the last five years.
