**Subject:** - Filling up of the post of Adviser to the Executive Director, International Monetary Fund (IMF), Washington, for a period of 3 years-reg.

Sir/Madam,

It is proposed to fill up the post of Adviser to the Executive Director, International Monetary Fund (IMF), Washington, for a period of 3 years.

2. Officers of the rank of Deputy Secretary / Director of the Government of India or equivalent level are eligible for the post. Officers applying for this post should possess the following qualifications and experience:-

**A. Mandatory Qualifications:-**

- 1) Minimum 2 years cumulative working experience in the Ministry of Finance / Economic.
- 2) Substantial graduate level university degree in areas related to the work of the Fund, most desirably, in Economics with an emphasis on Macroeconomics, Monetary Economics, and Public Finance and a sufficient depth of economic knowledge to be applied immediately in work assignment.
- 3) Familiarity with major Fund-related issues.

**B. Desirable Qualifications:-**

1. Experience of dealing with externally aided projects.
2. Preference may be given to those who have experience in the Department of Economic Affairs.
3. Degree in Economics or MBA or International Trade or Public Finance.


3. It is further required that:-

- (i) The officer must have worked for at least 2 years at the Centre under the Central Staffing Scheme.
- (ii) The officer should be clear from vigilance angle.
- (iii) The officer should not be debarred from Central deputation.
- (iv) The officer should have at least "Very Good" Service record.
- (v) The officer should not be over 54 years of age.
- (vi) The officer should not have been posted on an assignment in a foreign / captive post of the GOI, earlier.
- (vii) The officer should not have been nominated for foreign training or should not be on training or foreign assignment currently.
- (viii) The officer should not be on study leave or long leave.
- (ix) The officer should be at least one batch below the batch currently empanelled as Joint Secretary.

4. This post may be circulated amongst officers eligible to be appointed at the level of Deputy Secretary / Director in the Government of India on priority basis. Names of willing and eligible officers who can be spared by the State Governments / Ministries / Departments may be forwarded / faxed to this Department along with **Cadre clearance, Vigilance clearance, detailed Bio-data and certified ACR grading of the last five years**. It may also be ensured that the "Cooling Off", after a previous stint on deputation, if any, is complete and the officer is eligible to be appointed on Central Deputation as per rules.

5. It is requested that the application of the eligible candidate (s) may please be forwarded so as to reach this Department not later than  $14^{th}$  October, 2011.
