

**OFFICE MEMORANDUM**

***Subject: Debarment of Shri Somanath Shivarudrappa Ukkali, IRS (IT:2004).***

Shri Somanath Shivarudrappa Ukkali, IRS (IT:2004) was appointed as CVO, HMT Ltd., Bengaluru under the M/o Heavy Industries vide order dated 09.02.2024. The D/o Revenue was also requested to relieve him with the direction to join his new assignment as CVO, HMT Ltd. Since Shri Ukkali had informed that he is not in a position to assume the charge of the post of CVO, HMT Ltd., the D/o Revenue, vide this Department's O.M of even number dated 11.03.2024 was requested to bring the implications of not joining the assignment to the notice of Shri Ukkali so that on a later date, he may not represent that the adverse consequences of not joining as CVO, HMT Ltd. were not brought to his notice. In that notice it was also mentioned that if the officer does not join within 15 days from the date of receipt of the notice or the D/o Revenue does not relieve him, this Department shall go ahead with cancellation of his appointment and notify the debarment with attendant consequences.

2. M/o Heavy Industries has informed that Shri Somanath Shivarudrappa Ukkali, IRS (IT:2004) has not assumed the charge of the post of CVO, HMT Ltd. Hence, in accordance with para C(xi) of CVO guidelines dated 28.04.2017, the approval conveyed for the aforesaid appointment is hereby cancelled and Shri Somanath Shivarudrappa Ukkali, IRS (IT:2004) is debarred from all kinds of central deputation (including Central Staffing Scheme) for a period of 5 years w.e.f. 09.02.2024. In addition, he is also debarred from being given cadre clearance for any foreign assignment/consultancies abroad during the period of debarment as per the extant policy. Shri Somanath Shivarudrappa Ukkali, IRS (IT:2004) may accordingly be informed.
