Note:

- (1) * The employees of Kamarajar Port Limited holding equivalent posts with corresponding pay scale and length of service will be eligible for consideration.
- (2) The posts of Chairperson and Deputy Chairperson are Selection Posts for which the benchmark in overall grading of APARs for last five years should not be below 'Very Good'.
- (3) Applicants with left over service of 2 years or more (as on the date of arising of vacancy or closing date of submission of applications, whichever is later) will only be considered for appointment.
