OFFICE MEMORANDUM

Subject: Debarment of Shri Mahesh Deoram Akhade, IRS (IT:2002).

Shri Mahesh Deoram Akhade, IRS (IT:2002) was appointed as CVO, Goa Shipyard Ltd. (GSL), Goa vide this Department's order dated 22.03.2022. However, he expressed his unwillingness for joining the post of CVO, SJVNL. Therefore, a debarment notice was issued to Shri Akhade through his Cadre Controlling Authority (CCA) i.e. CBDT, D/o Revenue in terms of para C(xi) of CVO guidelines dated 28.04.2017, which stipulates, "Consequent to their selection to the post of CVO, if an officer does not join within the prescribed time, his appointment would be treated as cancelled and the officer concerned would stand debarred from all kinds of central deputation (including Central Staffing Scheme) for a period of five years from the date of issuing orders of his/her appointment. Further, the officer would also be debarred from being given cadre clearance for being deputed on foreign assignments/consultancies abroad during the period of debarment. However, before debaring an officer a notice shall be issued to him/her through the Cadre Controlling Authority (CCA)." In that notice it was mentioned that in case no reply is received from the CBDT, D/o Revenue or the officer does not join by 10.05.2022, or the CBDT, D/o Revenue does not relieve him, this Department shall go ahead with cancellation of his appointment and notify the debarment with attendant consequences.

2. Since, no communication has been received from CBDT, D/o Revenue till date and Shri Mahesh Deoram Akhade, IRS (IT:2002) has failed to join the post of CVO, GSL, Goa despite the opportunities given to him, in accordance with para C(xi) of CVO guidelines dated 28.04.2017, the approval conveyed for the aforesaid appointment is hereby cancelled and Shri Mahesh Deoram Akhade, IRS (IT:2002) is debarred from all kinds of central deputation (including Central Staffing Scheme) for a period of 5 years w.e.f. 22.03.2022. In addition, he is also debarred from being given cadre clearance for any foreign assignment/consultancies abroad, during the period of debarment as per the extant policy. Shri Mahesh Deoram Akhade, IRS (IT:2002) may accordingly be informed.
