2. It is requested that a copy of the order relieving Sh. Rajiv Wadhawan, ICoAS (2002) for the assignment along with a copy of the terms and conditions of the foreign assignment, may be sent to this Department for information and records.

It may also be noted that the deputationist officer is deemed to have been relieved on the date of expiry of the deputation period unless the competent authority has with requisite approvals, extended the period of deputation, in writing, prior to its date of expiry. In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse Civil/Service consequences which would include the period of overstay not being counted for service for the purpose of pension and that any increment due during the period of overstay being deferred with cumulative effect, till the date on which the officer rejoins in his parent cadre. Proceedings for deemed resignation from service would also be initiated. This may be brought to the notice of the officer.
