The Secretariat of the United Nations presents its compliments to the Permanent Missions of Member States to the United Nations and invites Member States to recommend qualified individuals to serve on the Panel of Experts established pursuant to resolution 1874 (2009) on the Democratic People's Republic of Korea (DPRK). The Panel of Experts on the DPRK, which is comprised of eight experts, operates under the direction of the Security Council Committee established pursuant to resolution 1718 (2006).

Nominations are sought for expert positions on the Panel of Experts on the DPRK that will become vacant in May 2023. Recommended candidates should possess a minimum of **ten years** of progressively responsible experience, with a minimum of three years of field experience, in the below mentioned relevant areas of expertise and competence:

- Customs and export controls
- Finance and economics
- Maritime transport
- Missile issues and other technologies
- Non-proliferation, procurement and trade
- Non-proliferation and regional security
- Nuclear issues
- Other weapons of mass destruction and conventional arms

The selection process will include an interview and other assessment methods to evaluate candidates' suitability. Sanctions experts are selected on the basis of demonstrated expertise in the relevant area of work, experience and educational background, with due regard to equitable geographic representation and gender balance. English and French are the working languages of the United Nations Secretariat. For these positions, fluency in English is required; knowledge of another UN official language is an advantage; knowledge of languages relevant to the Northeast Asia region is an advantage.

Appointment duration is in accordance with the mandate of the expert panel established by the Security Council. Experts are hired as consultants in line with the United Nations' administrative instruction concerning consultants and individual contractors (ST/AI/2013/4).
