2. Officers of the rank of Deputy Secretary/Director level from the All India Services or any Organized Group 'A' Services of the Government of India, eligible for appointment under Central Staffing Scheme are eligible for the above post. The period of deputation is 4/5 years at Deputy Secretary/Director level respectively.

4. The post is a Non-Central Staffing Scheme post to be filled up through the Civil Services Board (CSB) procedure. It may be noted that no 'Mandatory Posting Certificate' for allotment/retention of Government accommodation would be issued by this office to the officer appointed to the post.
