It is proposed to fill up one post of **Financial Advisor & Chief Accounts Officer (FA&CAO) (JS level)**, Employees Provident Fund Organisation (EPFO) under the Ministry of Labour & Employment with pay at Level 14 (Rs.1,44,200-2,18,200/-) of the Pay Matrix on deputation basis.

2.(a) Names of willing and eligible officers, who have been empanelled to hold Joint Secretary or equivalent posts at the Centre under the Central Staffing Scheme may be recommended to this office along with cadre clearance, vigilance clearance and detailed bio-data (through SUPREMO link: <https://supremo.nic.in>). In case the officers are currently on deputation outside the cadre, the nomination may be forwarded with the approval of the competent authority/Minister-in-charge concerned.

(b) The post is a Non-Central Staffing Scheme post to be filled up through the Civil Services Board (CSB) procedure. It may be noted that no 'Mandatory Posting Certificate' for allotment/retention of Government accommodation would be issued by this office to the officer appointed on the above referred post. However, those officers who have served and are currently serving on Central Staffing Scheme post in Delhi for at least four years and require to retain Government accommodation, would be issued a certificate to the effect that the officer concerned has served for at least four years in CSS post and he/she needs to retain Government accommodation for his/her tenure on non-CSS post.
