It is proposed to fill up the post of **MD & CEO (JS level), India International Convention and Exhibition Centre Limited (IICCL)** under the Department for Promotion of Industry and Internal Trade with pay at Level 14 of the Pay Matrix on deputation basis.

2.(a) Names of willing and eligible officers, who have been empanelled to hold Joint Secretary or equivalent posts at the Centre under the Central Staffing Scheme may be recommended to this office along with cadre clearance, vigilance clearance and detailed bio-data (through SUPREMO link: <https://supremo.nic.in>).
