Officers having an experience of a minimum: (i) three years as Chairperson in Category-II Port; <b>or</b> (ii) four years combined service as Deputy Chairperson of Category-I Port or above level post; <b>or</b> (iii) five years combined service as Deputy Chairperson in Category-II Port or above level post.
(ii) Rs.2,00,000-3,70,000/- (IDA pattern) for Port officers and KPL employees.		

Note:

- (1) \* The employees of Kamarajar Port Limited holding equivalent posts with corresponding pay scale and length of service will be eligible for consideration.
- (2) The posts of Chairperson and Deputy Chairperson are Selection Posts for which the benchmark in overall grading of APARs for last five years should not be below 'Very Good'.
- (3) Applicants with left over service of 2 years or more (as on the date of arising of vacancy or closing date of submission of applications, whichever is later) will only be considered for appointment.
