OFFICE MEMORANDUM

Subject: Debarment of Shri Anuj Kumar Sinha, IDSE(2007), from deputation under Central Staffing Scheme – reg.

Shri Anuj Kumar Sinha, IDSE(2007), was approved for appointment as Deputy Secretary in the D/o Water Resources, River Development and Ganga Rejuvenation, Delhi vide this Department's O.M. dated 23.04.2021 and the M/o Defence was requested to relieve him with the direction to join his new assignment in the D/o Water Resources, River Development and Ganga Rejuvenation. Since Shri Sinha did not join the assignment, the M/o Defence vide this Department's communication of even number dated 18.08.2021 was requested to bring to the notice of Shri Sinha, the implications of not joining the assignment so that on a later date he may not represent that the adverse consequences of not joining the assignment at the Centre under the Central Staffing Scheme were not brought in his notice. It was also pointed out that in case no reply was received or the officer did not join by 25.08.2021 or the M/o Defence did not relieve him, this Department would go ahead with cancellation of his appointment and notify his debarment with its attendant consequences.

2. Since, Shri Anuj Kumar Sinha, IDSE(2007), has failed to join the post of Deputy Secretary in the D/o Water Resources, River Development and Ganga Rejuvenation, Government of India, the approval conveyed to the aforesaid appointment is hereby **cancelled** and he is debarred from central deputation for a period of five years w.e.f. 23.04.2021. In addition to the debarment of Shri Sinha from central deputation, he is also debarred from taking up any foreign assignment/consultancies abroad, during the period of debarment as per the extant policy. Shri Anuj Kumar Sinha, IDSE(2007), may accordingly be informed.
