Subject: Filling up the post of General Manager (Region), Regional Office, Haryana in Food Corporation of India (Director level), under the Department of Food and Public Distribution.

Sir/Madam,

This is regarding filling up the post of General Manager (Region), Regional Office, Haryana in Food Corporation of India (Director level), under the Department of Food and Public Distribution on deputation basis. The post is a CSS post to be filled through the Civil Services Board(CSB) procedure. This post has been identified as a sensitive post and therefore, the tenure of the post as per the extant guidelines of Central Vigilance Commission will be for a period of 3 years.

2. Officers of the rank of Director level from the All India Services or any Organized Services of the Government of India, eligible for appointment under Central Staffing Scheme are eligible for the post. Further, having an experience of working with Food Procurement and Public Distribution System related matters may be treated as a desirable experience.
3. The post may be circulated amongst officers eligible to be appointed at Director level or equivalent level in the Government of India on priority basis. Names of willing and eligible officers who can be spared by the State Governments/Ministries/Departments may be forwarded to the Department along with **cadre clearance, vigilance clearance, detailed bio-data in the enclosed proforma and CR Dossiers for the last five years**. For officers working in the cadre, it may also be ensured that the 'Cooling off', after a previous stint on deputation, if any, is completed and the officer is eligible for appointment on Central Deputation as per extant instructions.
4. It is requested that the application(s) of the eligible candidate(s) may please be forwarded so as to reach this Department on or before **05.05.2023**.
5. Previous vacancy circular for the above post issued vide DoP&T vacancy circular No. 9/1/2023-EO(MM-II) dated 13.01.2023 stands cancelled.
