OFFICE MEMORANDUM

Subject:- Filling up of the post of Member, Staff Selection Commission (Joint Secretary level) in the pay scale of Rs.37,400-67,000 + Grade Pay-Rs.10,000/-, New Delhi on deputation basis.

One vacancy of Member, Staff Selection Commission with Headquarters at New Delhi in the pay scale of Rs. PB-4, Rs. 37,400-67,000 + GP-Rs.10,000/- (Joint Secretary level) is expected to arise with effect from 08.10.2009. The eligibility criteria as per Recruitment Rules for the post are given in the Annexure-I. Applications from eligible officers are being invited through this OM. The pay and other conditions of service of the selected officer will be regulated in accordance with this Department's OM.No. 2/29/91-Estt (Pay-II) dated 05th January, 94, as amended from time to time.

2. Application of only such officers will be considered as are routed through proper channel and are accompanied with (i) bio-data in the proforma at Annexure-II; (ii) the CR dossier of the officer with CRs up to 2007-2008 or clear photocopies of the CRs of the officer containing CRs of at least last five years, duly attested by a Group 'A' officer with a certificate that no "Adverse remarks" remain in the CRs for past years; (iii) cadre clearance; (iv) clearance from vigilance and disciplinary angle; and (v) statement giving details of major or minor penalties, if any, imposed on the officer during the last ten years and (vi) a certificate that in the event selection, the officer would be relieved to join the duties of the post with effect from 08.10.2009.

3. All Ministries/Departments are requested to forward the applications of willing and eligible officer in the prescribed proforma to: Shri Suneel K. Arora, Under Secretary to the Government of India, Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training), Room.No. 215-A-II, North Block, New Delhi-110001, so as to reach this office latest by 31.03.2009. Applications not accompanied with the required certificates/documents stated in para 2 above will not be entertained.

ANNEXURE-I

Eligibility criterion for the post of Member, Staff Selection Commission

1. Name of Post : Member, Staff Selection Commission (Hqrs), New Delhi.
2. Scale of Pay : PB-4, Rs. 37,400-67,000 + Grade Pay of Rs.10,000/- p.m.
3. Eligibility : Officers of the Central Government (including officers of All India Services and Central Group 'A' Services)
 - (a) (i) Holding analgous post on regular basis in the parent cadre/Department; or
(ii) with five years serve in the grade rendered after appointment thereto on regular basis in the scale of pay of Rs. 14,300-18,300/- (pre-revised) or, equivalent in the parent cadre/department;
and
 - (b) Possessing the following educational qualification and experience:-
 - (i) Post Graduate Degree in any discipline;
 - (ii) 10 years' experience in dealing with Service, Administrative, Vigilance, Establishment and Financial Matters.
4. **Period of Deputation**: The tenure of Member of the Staff Selection Commission is for a period of five years or till he attains the age of 62 years, whichever is earlier. In case an officer appointed as Member of the Staff Selection Commission retires on superannuation before completing the tenure of five years, he shall be deemed to be on re-employment terms for the remaining period of tenure subject to the upper age limit for 62 years.
5. **Age Limit**: The maximum age limit for appointment by deputation shall be not exceeding 59 years as on the closing date of the receipt of applications.
