3. (i) and (ii) A Committec of Officers of appropriate status unconnected with the original decision to retire the employee axy prematurely should be constituted. Final orders shall be passed by the appropriate authority only after obtaining the approval of the secretary in the Administrative Minietry/Department. Where, however, the order of premeture retirement was is sued by the President, itinal orders on the representation shall be paescd by the Minis ter-in-charge of the Ministry/Department concerned. In the casc of Indian Audit \& Accounts Leptt. employees, final ordere on such representation would be passed after approval by DY.C\&AG.
4. Officers who arc/were membere of orgenised services.

Notes In the casc of gazetted and non-gazetted officers balonging to the organised services, working in or under Miniotry Doptt., the revinw aholl be done in the Ministry/Department which is the cadre controlling authority to which the officer belonge. The cedre controlling authoritice should obtain the comments of the Ministrylfepartment in or unoser which the officer concerned is serving for the time being, and place the caec before the appropriate reviaw committece.
4. Committece set up by the ap:ropriate cadre controlling authorities on the lines indicated for Sl. No. 2 and 3 above. Final ordore will be pasecd by the authority mentioned against Sl.NO. 2 and 3 above, as the case may be.
