the proviso to article 309, read with clause (5) of article 148 of the Constitution, and after consultation with the Comptro ller and Au ditor General of India in relation to persons serving in the Indian Audit and Accounts Department, the Presid ent hereby make s the following rules further to amend the Fundamental Rules, namely:

1.(1) These Rules may be called the Fundamental (Second Amendment) Rules, 1989.

(2) They shall come into for ce on the date of their pur blication in the Official Gazette. In rule 56 of the Fundamental Rules, for Clause (j), the following clause shall be substituted, namely:-

- "(j) Notwithstanding anything contained in this rule, the appropriate authority shall, if it is of the opinion that it is in the public interest so to do, have the absolute right to rotire any Government servant by giving him notice of not less than three months in writing or three months' pay and allowances in lieu of such notice—
 - (i) If he is, in Group 'A' or Group 'B' service or post in a substantive, quasi-permanent or temporary capacity and had entered Government service before attaining the age of 35 years; after he has attained the age of 50 years;
 - (ii) in any other case, after he has attained the age o f 55 years;

Provided that nothing in this clause shall apply to a Government servant referred to in clause (e), who entered Government service on or before the 23rd July, 1966."
