SUBJECT: -Centrel Civil Services (Conduct) Rules, 1964-Acceptence of passage and hospitality by officers from foreign contracting firms.

The undersigned is directed to say that Covernment have had under consideration the question whether an officer may be permitted to accept the cost of offered by a foreign country and hospitality during his stay there by way of free board and lodging, if offered by a foreign firm contracting with the Government either directly or through its agents/ representatives in Idia. The exclanation below rule 13(1) of the General Civil Services (Conduct) hiles. 1:64. provides that Potent abait include hules, 1:64, provides that "offt" shall include free transport, bonding, lodging or other service or any other perindery seventing when provided by any person other tion a near relative or personal friand having no official dealings with the dovernment persont. Note II below the said mile further provide: the a Covernment servant shall avoid accepting Lavish hespitality or frequent hosp: telity from any individue having afficist dealings with him or from industrial or commercial firms, organisations etc. In the circumstances, Government have decladed that officers should neither accept, nor be permitted to accept, offers of the Cost of passage to foreign countries and houpitality by way of free board and lodging there, if such offers are made by foreign firms contracting with Government either directly or through their agen 22/representatives in India. The only exception to this will be in respect of facilities for training abread offered by foreign firm (who obligh re-imburschent from the foreign Governmencongarned) as part of aid programmes.
