OFFICE MEMORANDUM

Subject: Accommodation for Regulatory Authorities -

The undersigned is directed to refer to this Department's O.M. No. 3/6/97-Estt. (Pay II) dated the 29th Jan., 1998 regarding the perquisites and some important terms and conditions for the Chairperson and Members of the Regulatory Authorities and to say that clause (h) of the Annexure thereof provides for the matters relating to accommodation for them. Accordingly, the Chairperson and Members of a Regulatory Authority located in Delhi or in one of its satellite towns are given an option of claiming house rent allowance @ 30% of the basic pay drawn if they stay at Delhi but no house would be hired by the Authority or allotted by the Government. This provision, however, does not apply to the Regulatory Authorities located in other cities.

2. The question of extending the above provision to the Regulatory Authorities located in other cities has been considered by the Govt. and it has been decided to extend with immediate effect the above provisions to the authorities located in other metropolitan cities where they would be entitled to the House Rent Allowance at the rate admissible only for that metropolitan city.
