ORDER

Sanction of the President is hereby accorded to the grant of Rs. 1,55,000/- (Rupees One Lakh Fifty-Five Thousand Only) towards the first installment as Grants-in-aid within the overall limit of Rs. 3.10 lakhs to meet part of the annual recurring expenditure in connection with the running of the Secretariat of the Staff Side of National Council (JCM) during the year 2014-2015. 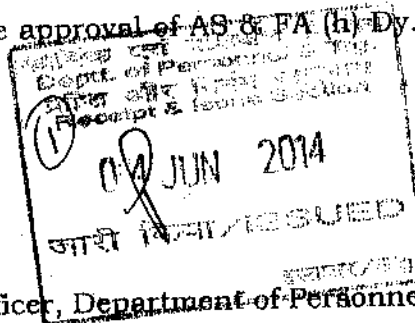
- (a) The grant-in-aid will be spent for the purpose for which it has been sanctioned viz., annual recurring expenditure of the Staff Side Secretariat;
- (b) The Secretary, Staff Side, National Council (JCM) shall furnish a copy of the annual accounts within three months of the close of current financial year;
- (c) The accounts for the Staff Side of the National Council (JCM) will be open for the test check by the Comptroller and Auditor General of India at his discretion; and
- (d) Any balance of the Grant-in-aid left unspent as on the 31st March, 2015 will be adjusted towards the Grant-in-aid, if any, which Government may pay during the next financial year.

2. The expenditure involved is debit to Major Head "2052" - Secretariat, General Services, Minor Head 00.090 Secretariat, 05 - Ministry of Personnel, Public Grievances & Pensions, 05.01 - Department of Personnel & Training, 05.01.31 - Grants-in-aid General under Demand No.73, Ministry of Personnel, P.G. & Pensions for the year 2014-2015.

3. The pattern of assistance in this case has been approved in consultation with the Ministry of Finance (Department of Expenditure).

4. The amount will be drawn by the Under Secretary (Cash), Department of Personnel and Training through a crossed A/c payee cheque in favour of the Secretary, Staff Side of the National Council (JCM), New Delhi.
