The undersigned is directed to refer to this Department's O.M. of even number dated 31st May, 2016 issued in pursuance of meeting in DoPT on the issue cited in subject above. All the participant Ministries/Departments were requested to send a proposal for amendment of the Recruitment Rules for the posts having Grade Pay of Rs. 4200/-, 4600/and 4800/- which are part of CGLE for the limited purpose of revising the upper age limit as 30 years, in consonance with the guidelines on framing/amendment of Recruitment Rules dated 31.12.2010. To expedite the amendment, the Ministries were also exempted from the procedure indicated in DoPT OM dated 13.10.2015 for placing the RRs on website for one month. However, it has come to the notice of DoPT that not all the Ministries/Departments have completed the notifying of completed the provision of notifying the amendment.

- 2. Further, DoPT vide OM dated 14.09.2016 requested all participating Ministries / Departments to convey the status for amendment of the RRs of the posts carrying Grade Pay Rs. 4200, 4600 & 4800/- and to furnish a copy of the notification of the Recruitment Rules.
- A statement indicating the status of the amendment in the upper age-limit is at 3. Annexure-I. It is noticed that the status regarding amendment of the RRs revising the upper age limit as 30 years from some Ministries/Departments is still awaited. Since it is a matter relating to various public grievances/representations and also causing hardships to the desirous candidates, a meeting has been scheduled under the Chairmanship of Joint Secretary (Estt.), DoPT on 23.03.2017 at 2.30. The officers at the appropriate level may kindly make it convenient to attend the meeting.
- 4. It is also requested to inform this Department about the current status of amendment or forward a copy of amended RRs (if amended) prescribing the upper age limit as 30 years for the posts for which recruitment is made under Combined Graduate Level Examination (CGLE) conducted by SSC as per DoPT guidelines on priority.
