2. The details of sum, being released, alongwith the conditions attached thereto are furnished in the Annexure.



- (ii) The General Financial Rules, 2017 should be followed while incurring the expenditure.
- (iii) UP Academy of Administration & Management, Lucknow should furnish to this Department for record and audit. Utilization Certificate in GFR 12-A Form duly countersigned by the Head of the Institute along with Achievement-cum-Performance Report as required under Rule 238 of General Financial Rules, 2017.
- (iv) The unutilized amount of grant, if any, may be surrendered to this Department by a Demand Draft drawn in favour of "Under Secretary (Cash), DOPT payable at New Delhi.
