2. The details of sum, being released, alongwith the conditions attached thereto are furnished in the Annexure.



(iv) ADMINISTRATIVE EXPENSES- Preparation of training materials, secretarial assistance, TA, Vehicle and other administrative expenses etc.	Rs.3,00,000/-

- (ii) The General Financial Rules, 2017 should be followed while incurring the expenditure.
- (iii) Administrative Training Institute, West Bengal should furnish to this Department for record and audit, Utilization Certificate in GFR 12-A Form duly countersigned by the Head of the Institute along with Achievement-cum-Performance Report as required under Rule 238 of General Financial Rules, 2017.
- (iv) The unutilized amount of grant, if any, may be surrendered to this Department by a Demand Draft drawn in favour of "Under Secretary (Cash), DOPT payable at New Delhi.
- (v) There should not be any overlap of activities under any other Scheme.
- (vi) The Institute should use Expenditure, Advance and Transfer (EAT) module of Public Financial Management System (PFMS) to make further payments.
