G.S.R. 542(E).—In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (61 of 1951), the Central Government, in consultation with the Government of Haryana hereby makes the following rules further to amend the Indian Administrative Service (Pay) Rules, 2007, namely:—
