ORDER

The Government of Madhya Pradesh vide their letter no. E-1/26/2012-5/1 dated 3rd February 2014 have requested to fix the seniority/year of allotment of Shri Vinod Kumar Sharma who has been appointed to IAS on the basis of inclusion of his name in the select list of 2011 vide this Department's notification dated 14015/13/2012-AIS-I B dated the 17th October 2013. Further the Government of Madhya Pradesh informed that Sharma has been holding the post of Deputy Collector on continuous basis from 13.6.1988.

2. Seniority/year of allotment of IAS officer appointed on the basis of Select List of 2011 has already been fixed seniority vide dated 6th December 2013. Seniority of Sharma was not alongwith others as the name of Sharma was provisionally included in the select list of 2011 subject to clearance in disciplinary proceedings pending against him. Subsequently, his inclusion was declared unconditional and final by UPSC on a proposal from State Government Shri Sharma was appointed to IAS vide notification dated 17.1.2014. From the select list it has been observed that the name of Shri Sharma was included at SL No. 11 in the select list below the name of Mukesh Kumar Shukla and above Smt. Alka Srivastava.

3. In view of the above, the seniority/year of allotment of Shri Sharma has been considered and computed under Rule 3(3) (ii) of IAS (Regulation of Seniority), Rules 1987, as amended from time to time and revised order of seniority of promotee IAS officers of Madhya Pradesh appointed on the basis of SL of 2011 incorporating details regarding Shri Vinod Kumar Sharma would be as under:-

3.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose names have been mentioned at Sl. No. 2 to 10 of the Select List of 2011 shall be placed below Shri Lokesh Kumar Jatav, the junior most RR IAS officer of 2004 batch and above Shri Rahul Jain, senior most RR IAS officer of Madhya Pradesh Cadre of 2005 batch.

3.3 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose names have been mentioned at Sl. No. 11 to 17 of the Select List of 2011 shall be placed below Shri Sanjeev Singh, the junior most RR IAS officer of 2005 batch and above Dr. Khade Sudam Pandharinath, senior most RR IAS officer of Madhya Pradesh Cadre of 2006 batch.

3.4 Seniority/year of allotment of officer at Sl. No. 4, 5 & 6 in the Select List of 2011 has been restricted under proviso to Rule 3(3)(ii) of IAS (Regulation of Seniority) Rules, 1987.

4. This Department's order of even number dated 12th December 2013 stands superseded to the above extent.
