**ORDER**

3.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, officers mentioned at Sl. No. 15 to 25 in the select list of 2016 shall be placed below Shri Asheesh Singh, a junior most RR IAS officer of 2010 batch and above Shri V.S. Choudary Kolasani, a senior most RR IAS officer of 2011 batch of Madhya Pradesh Cadre.
