

Mathuresh Babu Ojha, IAS (SCS: 2001), so far the junior most SCS:IAS officer of 2001 batch of Madhya Pradesh Cadre of IAS and above Sh. N.S. Bhatnagar, IAS (Non- SCS: 2001) so far the junior most IAS officer of 2001 batch of Madhya Pradesh Cadre of IAS.

2.1 Further, the officers whose names have been mentioned at Sr. No.3 to 11 for the Select List of 2008A and at Sr. No.1 for the Select List of 2009 shall be placed enblock below Sh. Borkar Chandrashekhar, IAS (RR: 2002), so far the junior most IAS officer of 2002 batch and above Dr. Sanjay Goel, IAS (RR:2003) so far the senior most direct recruit IAS officer of 2003 Batch of Madhya Pradesh Cadre of IAS.


