**ORDER**

The Government of Odisha vide their letter no. SER1-IAS-0013-2013-4686/AIS-I dated 15<sup>th</sup> February 2014 have requested to fix seniority/year of allotment of Shri Chudamani Seth of Odisha cadre, who has been appointed to IAS by promotion from SCS on the basis of Select List of 2012 vide this DOPT's notification No. 14015/17/2013-AIS-I(B) dated 06.02.2014.

2. In this connection, it is mentioned that seniority/year of allotment of IAS officers appointed on the basis of Select List of 2012 has already been fixed seniority vide order of even number dated 12<sup>th</sup> December 2013. Seniority of above officer could not be fixed alongwith other officers as he was provisionally included in the select list of 2012 subject to clearance in criminal proceedings pending against him. Subsequently inclusion of his name in the said select list was declared unconditional and final by UPSC on a proposal from State Government. Consequently Shri Chudamani Seth was appointed to IAS vide notification dated 28<sup>th</sup> October 2013.

3. From the select list, it has been observed that Shri Chudamani Seth was included below Shri Manoranjan Patnaik-2 and and above Shri Dhiren Kumar Patnaik at Sl. No. 7.

4. In view of the above, the seniority/year of allotment of Shri Chudamani Seth have been considered and computed under Rule 3(3) (ii) of IAS (Regulation of Seniority), Rules 1987, as amended from time to time and revised order of seniority of promotee IAS officers of Odisha cadre appointed on the basis of SL of 2012 incorporating details regarding Shri Chudamani Seth would be as under:-
