ORDER

In compliance with the directions of Hon'ble CAT, Bangalore Bench order dated 8.9.2015 in OA No.706 of 2015 and in consultation with the State Government, this Department has appointed Captain Dr. K. Rajendra to IAS on the basis of inclusion of his name in Review Select List of 2013 vide Notification No. 22012/77/2015-AIS-(I) (B) dated 17.8.2017 and placed at Sl. No.10 by adding his name in the Select List of 2013.

2. In view of the above and on receipt of the proposal from the Government of Karnataka vide their letter no. DPAR 547 SAS 2017 dated 25.11.2017, the seniority/year of allotment of Captain Dr. K.
