ORDER

The Government of Uttar Pradesh had sent a proposal vide their letter no. 5567/2-1-2015-29/1(1)/2011 dated 1st October, 2015 for fixation of seniority / assigning the year of allotment to the officers appointed to IAS from State Civil Service on the basis of inclusion of their names in select lists for the **year 2014**(against vacancies arisen between 1.1.2014 to 31.12.2014).
