Revision in years of allotment of Shri M.S. Sehrawat, O.P. Langayan and Smt. Suprapha Dahiya in compliance of order dated 24.5.2010 of the CAT, Chandigarh Bench in O.A. No. 314/CH/2009.

Sir,

I am directed to refer to subject above noted and to say that the seniority of Shri M.S. Sehrawat, appointed to the IAS against the select list of 1999, was fixed as 1995 vide this Department's letter No. 14014/39/99-AIS(I) dated 20.8.2002 taking into account his actual service rendered in the HCS w.e.f. 20.2.1984. The seniority of Shri O.P. Langayan and Smt. Suprapha Dahiya who were though entitled for higher years of allotment was restricted to that of Shri M.S. Sehrawat i.e. 1995 by virtue of the provisions of proviso to Rule 3(3)(ii) of the IAS (Regulation of Seniority) Rules, 1987.

2. Shri M.S. Sehrawat claimed benefit for fixation of seniority for his deemed service in the HCS for the period from 6.9.1983 to 20.2.1984. He filed an OA No. 314/CH/2009 in the CAT Chandigarh Bench seeking directions for revision of his year of allotment from 1995 to 1994 on the basis of his such notional service prior to his actual service w.e.f. 20.2.1984 in the HCS. The OA was disposed of by an order dated 24.5.2010 with the following directions:-

"In view of above, the OA is allowed and the applicant is held entitled to the weightage of 5 years for 15 years' completed service in State Civil Service on the post of Deputy Collector upto 31.12.1998, reckoned against the select list of 1999 and thereby he is held entitled to 1994

as the year of allotment instead of 1995 as has been done in the case of Sh. Doon. Respondent No. 1 is directed to comply with this order within a period of 3 months from the date of receipt of a copy of this order. No costs."

3. In compliance of the aforesaid Order dated 24.5.2010 of the CAT Chandigarh Bench, the matter has been reconsidered and the revised particulars for fixation of seniority of Shri M.S. Sehrawat are as follows:-

- 4. Therefore, in partial supersession of this Department's letter No. 14014/39/99-AIS(I) dated 20.8.2002 (so far as it concerns the fixation of seniority of Shri M.S. Sehrawat, IAS) and in compliance of the directions in Order dated 24.5.2010 of the CAT, Chandigarh Bench in O.A. No. 314/CH/2009 the year of allotment of Shri M.S. Sehrawat, appointed to the IAS against the select list of 1999, is revised from 1995 to 1994.
- 5. Shri O.P. Langayan and Smt Suprapha Dahiya had 18 and 15 years of service in the HCS respectively to their credit and were entitled for higher year of allotment than that of 1995 to which their seniority was restricted with that of Shri M.S. Sehrawat under proviso ibid. Now the seniority of Shri M.S. Sehrawat is being revised from 1995 to 1994 the seniority of these two officers is also revised from 1995 to 1994 in partial modification of this Department's letter No 14014/39/99-AIS(I) dated 20.8.2002 in so far as it relates to fixation of seniority of these officers.

6. For the purpose of inter-se seniority S/Shri M.S. Sehrawat, O.P. Langayan and Smt. Suprapha Dahiya shall be placed en bloc below Shri R.S. Doon, IAS (SCS:1994) in terms of Rule 4 of the IAS (Regulation of Seniority) Rules, 1987.
