ORDER

The Government of Gujarat vide their letter no. 2.1 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name has been mentioned at Sl. No. 1 to 12 of the select list of 2013 shall be placed below Shri Ravi Kumar Arora, Junior most RR IAS officer of 2006 batch and above Ms. Ardra Agrawal, senior most RR IAS officer of Gujarat Cadre of 2007 batch.

2.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name has been mentioned at Sl. No. 13 to 19 of the select list of 2013 shall be placed below Shri Sandip Janardan Sangle, junior most IAS officer of 2007 batch and above Shri Dhawal Kumar Patel senior most RR IAS officer of Gujarat Cadre of 2008 batch.

2.3 Seniority /year of allotment of officers at Sl. No. 14 to 16 and 19 of the select list of 2013 has been restricted under proviso to Rule 3(3) (ii) of IAS (Regulation of Seniority) Rule, 1987.
