





Shahid Anayatullah, IAS (SCS: 2000), so far the junior most IAS officer of 2000 batch and above Sh. Mandeep K Bhandari, IAS (RR: 2001) so far the senior most IAS officer of 2001 batch of J&K Cadre of IAS.

2.1 Further, the officers whose names have been mentioned at Sr. No.2 to 4 for the Select List of 2008A and at Sr. No.1 to 15 for the Select List of 2009 shall be placed enblock below Sh. Sanjeev Verma, IAS (RR;2001), so far the junior most IAS officer of 2001 batch and above Sh. Saurabh Bhagat, IAS (RR:2002) so far the senior most direct recruit IAS officer of 2002 Batch of J&K Cadre of IAS.

3. The order may be conveyed to the concerned officer.




