ORDER

The Government of Manipur vide their No. 3/2/2015-IAS/DP dated 15th October, 2015 have requested to fix seniority/year of allotment of promotee IAS officers of joint Manipur-Tripura cadre, who have been appointed to IAS on the basis of inclusion of their names in the Select List of 2014 (SCS quota), vide this Ministry's notification No. 14015/15/2013-AIS-I B dated 18th September, 2015.
