With reference to Government of Andhra Pradesh letter No. 20/SPECIAL.A/A3/2009 dated 2nd July 2012, the question of fixation of seniority/year of allotment of the officers who were appointed to IAS by promotion from the Select Lists of 2009-A vide Ministry's notification No. 14015/03/2009-AIS-I dated 18th June 2010 has forwarded a proposal for fixation of seniority/year of allotment of SCS officers appointed to IAS on the basis of inclusion of their names in the select list of 2009A. No. 1 of the select list of 2009A (Against the vacancies of 2009) shall be placed below Shri P. Bhaskara, IAS the junior most promotee IAS officer (SCS) of 2005 batch and above Shri Pravin Kumar, the senior most direct recruit IAS officer of 2006 batch of Andhra Pradesh cadre.



2.1 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose names have been mentioned at Sl. No.2 & 3 of the select list of 2009A (Against the vacancies of 2009) shall be placed below Shri Gorrela Suvarna Panda Das, the junior most direct recruit IAS officer of 2006 batch and above Shri Mutyalaraju Revu, the senior most direct recruit IAS officer of 2007 batch of Andhra Pradesh cadre.

2.2 Seniority/year of allotment of Shri T.Babu Rao Naidu has been restricted under proviso to Rule3 (3)(ii) of IAS (Regulation of Seniority), Rules,1987.
