ORDER

The Government of Chhattisgarh vide their letter no. E-1-1/2012/1/2 dated 19.3.2015 have sent a proposal for fixation of seniority of IAS officers appointed on promotion from **State Civil Service (SCS)** on the basis of inclusion of their names in the **select list of 2011**.
