## **ORDER**

Shri Vijay Kumar Dhurve and Km Reeta Shandilya State Civil Service Officers of Chhattisgarh were appointed to IAS vide notification No. 14015/5/2010-AIS(I)-B dated 10.5.2011 for the Select of 2009A(Vacancies of 2009).
