**Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 30/09/2015 to consider the cases of inter cadre deputation/ inter cadre transfer requiring relaxation of provision(s) of the guidelines.**

A meeting was held on 30/09/2015 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer requiring relaxation of provision(s) of the guidelines. The members of the committee EO & AS and AS(S&V) were also present. Besides US(S-II) was also present to assist the Committee in the meeting;

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 22/09/2015.

The Committee thereafter took the fresh cases and after detailed deliberations and careful consideration in each case, took following decisions in the meeting:-

**Case 1: Extension in Inter cadre deputation period of Dr. Anoop Kumar Yadav, IAS, (MH:2002) from Maharashtra cadre to Uttar Pradesh cadre for further two years w.e.f. 02/04/2016**

The Committee was informed that the Central Government had granted approval for the inter cadre deputation to Shri Anoop Kumar Yadav, IAS (MH:2002) from Maharashtra cadre to Uttar Pradesh cadre for a period 3 years w.e.f. the date Shri Anoop Kumar Yadav assumed the charge of the post, vide notification dated 22/03/2013.

The Committee took into consideration the present proposal from the Government of Uttar Pradesh seeking for extension in the inter cadre deputation period of Shri Yadav from Maharashtra cadre to Uttar Pradesh cadre for further two years and after deliberation approved the proposal subject to grant of no objection from the Government of Maharashtra. Thereafter, the Committee directed that the proposal along with ACC note, may be put up expeditiously for consideration and approval of ACC.

**Case No. 2: Inter cadre deputation of Smt Damyanti Dohre, IAS (UP) from Uttar Pradesh cadre to Uttarakhand cadre**

The committee after deliberation directed that both the above cases (Case No. 2 & 3) be submitted with updated status on their individual files.

**Case 4: Cadre change of Shri Rajesh Singh, IAS (AM:07) from Assam – Meghalaya cadre, on the basis of PH policy dated 14/02/2014**

The Committee was informed that "no objection" from the State of Jharkhand has been received while comments from State Government of Uttar Pradesh and West Bengal are yet to be received. The Committee decided that on the request for the cadre transfer of the officer from Assam Meghalaya cadre to Jharkhand cadre, ACC note for the proposal may be put up.

**Case 5: Shri Killu Siva Kumar Naidu, IAS(MT:11) Inter cadre transfer from Manipur-Tripura cadre to Telangana cadre on the grounds of marriage to Ms Chetana Mylabathula, IPS(TG:13).**

The Committee was informed that the above proposal was originally considered in the meeting held on 15/04/2015 wherein it was observed that as per examination dossiers the permanent address of the officer is Vishakhapatnam which comes under Andhra Pradesh. Therefore, the request of the officer for proposed Inter cadre transfer is covered under the extant policy on inter cadre transfer and comments of the concerned State Governments are yet to be sought.

The Committee was informed that the State Government of Manipur had conveyed its consent vide its letter dtd 13/05/2015 and that now the State Government of Telangana vide its letter dated 29/09/2015 has also conveyed its consent for the cadre transfer of Shri Sri Killu Sivakumar Naidu, IAS (MT:2011). After deliberation, the Committee directed that the proposal may be put up for the approval of Secretary (P) through EO & AS.
