

Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 17.05.2016 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.

A meeting was held on 17.05.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The members of the committee EO & AS and AS(S&V) were also present. Further, Director, AIS & US (S-III) were also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 06.05.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

Case 1: Extension of inter cadre deputation of Shri Maneesh Chauhan, IAS (UP:2000) from Uttar Pradesh cadre to Rajasthan cadre

The Committee was informed that Shri Maneesh Chauhan, IAS (UP:2000) has requested for extension of inter cadre deputation from Uttar Pradesh cadre to Rajasthan cadre for a further period of 2 years. The officer has been granted Supertime scale w.e.f. 01.01.2016. **The Committee after detailed discussion decided that extension of inter cadre deputation of an officer after reaching Supertime Scale may not be recommended. However, some precedents for the year 2010-14 and 2014-till date may be listed and conveyed to ACC. Further, desired changes in the policy as required to clarify the above point may also be included.**

Case 2: Request for extension of deputation of Ms. A. Mona Sreenivas, IAS (HY:06) from Haryana cadre to AGMUT cadre for a further period of two years.

The Committee was informed that Ms. A. Mona Sreenivas, IAS (HY:06) has requested for extension of deputation period for a further period of two years beyond 11.07.2016 on personal grounds. **The Committee after detailed deliberations directed to reconcile her case with her spouse Shri A. Sreenivas, IAS (HY:04) and put up in next meeting.**

Case 3: Extension of inter cadre deputation of Dr. Joram Beda, IAS (PB:2008) from Punjab cadre to Arunachal Pradesh cadre for a further period of two years beyond 21.01.2017

The Committee was informed that Dr. Joram Beda, IAS (PB:2008) has requested for extension of inter cadre deputation from Punjab cadre to Arunachal Pradesh cadre for a further period of two years beyond 21.01.2017. **The Committee after detailed deliberations recommended the proposal and directed to seek comments from State Government of Punjab and vigilance status of the officer. Thereafter, on receipt of requisite comments / no objection, the proposal along with ACC note may be put up for the approval of ACC.**

Case 4: Draft Policy for allocation of PH candidates to the various cadres of Indian Administrative Services.

The Committee after detailed deliberations directed to put up the policy on file.

Case 5: Status of PH category officers whose cadre transfer is under process

The Committee was informed the status of PH category officers whose cadre transfer is under process. **The Committee after detailed deliberations directed to seek necessary clarification from the concerned State Governments expeditiously but before 31st May 2016.**
