

Minutes of the meeting held under the chairmanship of Secretary, DOP&T on 19.12.2016 to consider the cases of inter cadre transfer / deputation / extension of inter cadre deputation requiring relaxation of provision(s) of the guidelines.

A meeting was held on 19.12.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer requiring relaxation of provision(s) of the guidelines. The members of the committee EO&AS & AS(S&V) were present. Further, DS(AIS) & US(S-III) were also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 18.11.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

Case 1: Extension of inter cadre deputation period in respect of Shri B. Kalyan Chakravarthy, IAS (AM:1995) from Assam-Meghalaya cadre to Telangana cadre on medical grounds for a further period of 3 years beyond 01.02.2017.

The Committee was informed that Shri B. Kalyan Chakravarthy, IAS (AM:1995) was granted inter cadre deputation to Telangana cadre for a period of 2 years in relaxation of guidelines regarding super time scale on grounds of extreme hardship of medical nature. He has now requested for extension of inter cadre deputation for a further period of 3 years on medical grounds. The Committee after detailed deliberations recommended the proposal and directed to put up the ACC note accordingly after receipt of vigilance clearance of the officer.

Case 2: Extension of inter cadre deputation of Ms. Sonali Ponkshe Vayangankar, IAS (MP:2000) from Madhya Pradesh cadre to Maharashtra cadre for a further period of two years beyond September, 2017.

The Committee was informed that Ms. Sonali Ponkshe Vayangankar, IAS (MP:2000) was granted inter cadre deputation to Maharashtra cadre for a period of 5 years. She has now requested for extension beyond five years. The Committee after detailed deliberations did not recommend the proposal as the proposal is not covered under extant guidelines.

Case 3: Extension of inter-cadre deputation of Shri Ashish Singhmar, IAS (HP:08) from Himachal Pradesh cadre to Jharkhand cadre for a further period of two years beyond 25.02.2017.

The Committee was informed that Shri Ashish Singhmar, IAS (HP:08) was granted inter cadre deputation to Jharkhand cadre for a period of 3 years under special dispensation available in the Policy. He has now requested for extension to Jharkhand cadre. Both the State Governments have conveyed their consent. The Committee after detailed deliberations recommended the proposal and directed to put up ACC note for the approval of ACC.

Case 4: Inter cadre deputation of Shri Ajay Katesaria, IAS (MP:2012) from Madhya Pradesh cadre to Jharkhand cadre on grounds of Jharkhand policy

The Committee was informed that Shri Ajay Katesaria, IAS (MP:2012) has requested for inter cadre deputation to Jharkhand on grounds of special provision for

inter cadre deputation to Jharkhand cadre. Further, both the state Governments have conveyed their consent. The Committee also noted that the Vigilance Clearance in respect of the officer is pending. The Committee after detailed deliberations did not recommend the proposal.

Case 5: Inter cadre deputation of Shri Jayant Narlikar, IAS (AM:2003) from Assam -Meghalaya cadre to Uttar Pradesh cadre presently on Central deputation.

The Committee was informed that Shri Jayant Narlikar, IAS (AM:2003) is on central deputation since June, 2014. He has requested for inter cadre deputation in continuation to Central deputation which requires waiving of cooling off period. The Committee after detailed deliberations recommended the proposal and directed to seek the consent /comments of the concerned States and vigilance clearance and thereafter put up the ACC note accordingly.

Case 6: Inter cadre transfer of Shri Megha Nidhi Dahal, IAS (AM:2015) from Assam-Meghalaya cadre to Sikkim cadre

The Committee was informed that Shri Megha Nidhi Dahal, IAS (AM:2015) has requested for inter cadre transfer to Sikkim cadre. Sikkim is the home state of the officer. The Committee after detailed deliberations decided to defer the case for the time being.

Case 7: Inter cadre transfer of Ms K Radhika Aiyar, IAS(WB:11) from West Bengal cadre on the grounds of PH policy dated 14.02.2014

The Committee was informed that State Government of West Bengal has forwarded clarification from the officer regarding the hardship being faced by the officer in her already allocated cadre. The Committee after detailed deliberations recommended the proposal for U.P. and directed to put up the same on file accordingly.
