ORDER

Consequent upon appointment of officers of Bihar Cadre from State Civil Services to IAS (**against SCS quota**) on the basis of inclusion of their names in the Select Lists of 2018 and 2019 vide this Department's Notification No.14015/04/2020-AIS-(I)-B dated 24.08.2022 and on receipt of the proposal from the Government of Bihar vide their letter No.1/C-1014/2021-GAD-15432 dated 31.08.2022, the seniority/year of allotment of the officers has been determined vide this Department's order of even number dated 21.09.2022.

2. The State Government of Bihar now vide their letter No. 1/C-1006/2016-GAD-19715 dated 07.11.2022 has intimated that Shri Birendra Prasad who has been appointed to IAS from the Select List 2019 is holding the post of Deputy Collector with effect from 28.05.1992 instead of 28.05.1993 as intimated earlier due to typographic error.

3. In view of the above, the seniority/year of allotment of the officers of Select List 2019 is hereby re-determined under Rule 3(3)(ii) of the IAS (Regulation of Seniority) Rules, 1987, and other relevant rules as amended from time to time. The weightage formula is as under:-
