G.S.R. 470(E).—In exercise of the powers conferred by sub-section (i) of Section 3 of the All India Services Act, 1951 (61 of 1951), the Central Government, in consultation with the Government of **Telangaña** hereby makes the following rules further to amend the Indian Administrative Service (Pay) Rules, 2007, namely:—

- 1. (1) These rules may be called the Indian Administrative Service (Pay) Amendment Rules, 2016.
 - (2) They shall come into force on the date of their publication in the official Gazette.
