GS.R. 54(E).— In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (61 of 1951), read with sub-rule (2) of rule 4 of the Indian Administrative Service (Cadre) Rules, 1954, the Central Government, in consultation with the Government of **Gujarat**, hereby makes the following regulations further to amend the Indian Administrative Service (Fixation of Cadre Strength) Regulations, 1955, namely:-

- 1. (i) These Regulations may be called the Indian Administrative Service (Fixation of cadre Strength) Amendment Regulations, 2013.
 - (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the schedule to the Indian Administrative Service (Fixation of Cadre Strength) Regulations, 1955, for the heading "Gujarat" and the entries occurring there under, the following shall be substituted namely:-
