

**Seniority/year of allotment of officers mentioned at Sl. No. 3 and 5 in the Select List of 2019 (Non-SCS Category) has been restricted under provisions of the rule 3(3)(iii) of IAS (Regulation of Seniority) Rules, 1987 which provide that an officer shall not be assigned year of allotment earlier than year of allotment assigned to other officer senior to him in that Select List or appointed on the basis of earlier Select List.*
