

Minutes of the meeting held under the chairmanship of Secretary, DOP&T on 18.11.2016 to consider the cases of inter cadre deputation/ inter cadre transfer requiring relaxation of provision(s) of the guidelines.

A meeting was held on 18.11.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer requiring relaxation of provision(s) of the guidelines. The members of the committee EO&AS & AS(S&V) were also present. Further US(S-III) was also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 17.10.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

Case 1: Inter cadre deputation of Shri Rahul Ranjan Mahiwal, IAS (MH:2005) from Maharashtra cadre to Bihar cadre

The Committee was informed that Shri Rahul Ranjan Mahiwal, IAS (MH:2005) has requested for inter cadre deputation from Maharashtra cadre to Bihar cadre. The officer being of 2005 batch has completed the required period of 9 years and has not reached supertime scale. Both the state Governments i.e. Maharashtra and Bihar have conveyed consent/no objection for inter cadre deputation of the officer. The Committee after detailed deliberations recommended the proposal and directed to put up ACC note for the approval of ACC.

Case 2: Inter cadre deputation of Shri Bhaskar Jyoti Sarma, IAS (OR:1999) from Odisha cadre to Assam Segment of Assam-Meghalaya joint cadre.

The Committee was informed that Shri Bhaskar Jyoti Sarma, IAS (OR:1999) has requested to reconsider his proposal on the grounds that as his spouse has been recommended for inter cadre deputation to Assam. Further, the State Government of Assam has conveyed its consent in the proposal. The Committee after detailed deliberations directed to seek comments/consent from State Government of Odisha at present.

Case 3: Inter cadre deputation of Shri Rahul Singh, IAS (AGMUT:2013) from AGMUT cadre to Haryana cadre for a period of 3 years

The Committee was informed that Shri Rahul Singh, IAS (AGMUT:2013) being of 2013 batch has not completed nine years of service in his cadre. However, State Government of Haryana has conveyed consent for inter cadre deputation. The Committee after detailed deliberations did not recommend the case as the proposal is not covered under the extant guidelines and directed to incorporate the case in the quarterly report to be submitted to ACC.

Case 4: Extension of inter cadre deputation of Smt. Gurneet Tej, IAS (KN:2006) from Karnataka cadre to Punjab cadre for a further period of two years beyond 30.04.2017.

The Committee was informed that Smt. Gurneet Tej, IAS (KN:2006) has requested for extension of inter cadre deputation from Karnataka cadre to Punjab cadre for a further two years. The Committee after detailed deliberations recommended the proposal and directed to put up ACC note for the approval of ACC.

Case 5: Extension of inter cadre deputation of Shri Gitte Kirankumar Dinkarrao, IAS (TR:2005) from Tripura cadre to Maharashtra cadre for a further period of two years beyond 03.02.2017.

The Committee was informed that Shri Gitte Kirankumar Dinkarrao, IAS (TR:2005) has requested for extension of his inter cadre deputation period from Tripura cadre to Maharashtra cadre for a further period of two years beyond 03.02.2017. The Committee was also informed that vigilance status in respect of the officer is awaited. The Committee after detailed deliberations recommended the proposal and directed to put up ACC note for the approval of ACC on receipt of vigilance clearance in respect of the officer.

Case 6: Extension of inter cadre deputation of Ms. A. Shainamol, IAS (HP:07) from Himachal Pradesh cadre to Kerala cadre for a further period of two years beyond 22.02.2017.

The Committee was informed ACC note for extension of inter cadre deputation of Ms. A. Shainamol, IAS was earlier put up to the level of Secretary (P), however, the same was referred to be put up 3-4 months before the expiry of tenure. The Committee after detailed deliberations recommended the proposal and directed to put up ACC note for the approval of ACC on receipt of vigilance clearance in respect of the officer.
