Subject: - IAS (Pay) Rules, 1954 - fixation of pay of IAS officers appointed as Directors in the Central Government - regarding.

Sir.

am directed to refer to our letter No.11030/15/92dated 8.9.94 Whereby it was clarified that if serving at the Centre as a Director i.S cleared promotion in the Supertime Scale in the cadre, he would option to either revert to his cadre to avail of the benefits of such promotion or to continue drawing pay Selection Grade while working as Director. The procedure, if such officer desires to revert to the cadre, was also outlined the said letter.

- A question has been raised as to the entitlements of an officer who starts getting pay in the Supertime Scale in the cadre before being appointed as a Director at the Centre. The practice so far adopted in such cases has been to allow him or her pay only in the Selection Grade at the Centre, in which grade Directors are appointed as per the provisions of Schedule III-C of the IAS(Pay) Rules, 1954, on the basis of his/her presumptive pay in the Selection Grade which he or she would have got in the cadre in the Selection Grade but for his or her appointment in the Supertime Scale, leading to an erosion in emoluments.
- 3. The matter to minimize the hardship in such cases has been carefully examined. It has now been decided that in case where an IAS officer has received promotion in Supertime Scale in his or her cadre and has <u>started</u> drawing pay in this grade, before his deputation to Government of India, he or she would be allowed the maximum of the Selection Grade viz. Rs.5700/- on his or her

appointment as Director at the Centre. In addition, in acccomment with the provisions of Schedule III-C <u>ibid</u>, he or she would be eligible to get Central (Deputation on Tenure) Allowance @ 15% of his/her grade pay subject to the conditions that the Central (Deputation on Tenure) Allowance does not exceed Rs.500/- per month and pay thus allowed plus Central (Deputation on Tenure) Allowance do not exceed Rs.6150/- per month.

- 4. This would apply <u>mutatis mutandis</u> in the cases of the members of the Indian Police Service and Indian Forest Service also.
- 5. It is requested that the contents of this letter may be brought to the notice of all concerned.
- 6. Hindi version will follow.
