

**Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 06.05.2016 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.**

A meeting was held on 06.05.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The member of the committee AS(S&V) was also present. Further, Director, AIS & US (S-III) were also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 19.04.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

**Case 1:** Request for inter cadre deputation of Mrs. S. Chhakchhuak, IAS (GJ:2008) from Gujarat cadre to Assam cadre.

The Committee was informed that Mrs. S. Chhakchhuak, IAS (GJ:2008) has requested for inter cadre deputation from Gujarat cadre to Assam cadre for a period of five years on personal grounds. Further, it was also informed that the policy for Inter cadre transfer/deputation for North East is under review. **The Committee after detailed deliberations directed to defer the proposal for the time being as the policy for Inter cadre transfer/deputation for North East is under review.**

**Case 2:** Request for inter cadre deputation of Mr. Surpreet Singh Gulati, IAS (PB:2008) from Punjab cadre to Assam cadre.

The Committee was informed that Mr. Surpreet Singh Gulati, IAS (PB:2008) has requested for inter cadre deputation from Punjab cadre to Assam cadre on personal grounds. Further, it was also informed that the policy for Inter cadre transfer/deputation for North East is under review. **The Committee after detailed deliberations directed to defer the proposal for the time being as the policy for Inter cadre transfer/deputation for North East is under review.**

**Case 3:** Inter cadre deputation of Smt. Sonal Goel, IAS (TR:2008) from Tripura cadre to Haryana cadre for a period of five years

The Committee was informed that Smt. Sonal Goel, IAS (TR:2008) has requested for inter cadre deputation from Tripura cadre to Haryana cadre for a period of five years. Further, it was also informed that the State Government of Tripura has conveyed no objection for inter cadre deputation of the officer. **The Committee recommended the proposal and directed to seek comments of State Government of Haryana and vigilance status of the officer. Thereafter, on receipt of requisite comments / no objection, the proposal along with ACC note may be put up for the approval of ACC.**

**Case 4:** Inter cadre transfer of Ms. Anjali Yadav, IAS (NL:15) from Nagaland cadre to Jharkhand cadre on grounds of marriage to Shri Bhor Singh Yadav, IAS (JH:14)

The Committee was informed that Ms. Anjali Yadav, IAS (NL:15) has requested for inter cadre transfer from Nagaland cadre to Jharkhand cadre on grounds of marriage to Shri Bhor Singh Yadav, IAS (JH:14). The home state of the

officer is Delhi. **The Committee recommended the proposal and directed to seek the comments of State Governments of Nagaland and Jharkhand and vigilance status of the officer. Thereafter, on receipt of requisite comments / no objection, the proposal may be put up for the approval of Secretary (P) through EO & AS.**

**Case 5:** Change of cadre of Shri Barun Kumar Sahu, IAS (TR:92) from Tripura cadre to Assam-Meghalaya cadre on personal grounds.

The Committee was informed that Shri Barun Kumar Sahu, IAS (TR:92) has requested for inter cadre transfer from Tripura cadre to Assam-Meghalaya cadre on personal grounds. As per policy, All India Service Officers belonging to North East cadre may be allowed transfer of cadre to any other cadre in the North East in relaxation of existing conditions subject to availability of deficit in insider quota. The Committee observed that the officer belongs to Jharkhand and not to North East. **The Committee after detailed deliberations did not recommend the proposal.**
