ORDER

Secretary Ministry of Home Affairs Vs Kavindra Pratap Singh and 16 Others) pending in Hon'ble High Court of Allahabad, Allahabad Bench and WRIT A 7517 of 2022 (Union of India Thru. Secy. Ministry of Personnel Public Grievances and Pensions, New Delhi Vs Central Administrative Tribunal, LKO. Thru. its Member and 2 others) pending before the Hon'ble High Court of Allahabad, Lucknow Bench.
