No. 1 of the select list of 2010 shall be placed below Shri Mohinder Pal Arora, the junior most promotee IAS officer of 2004 batch (Select list of 2009) and above Dr. Basant Garg, the senior most direct recruit IAS officer of 2005 batch of Punjab Cadre.

2.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose names have been mentioned at Sl. No. 2 to 7 of the select list of 2010 shall be placed below Shri Diparva Lakra, the junior most promotee IAS officer of 2005 batch and above Dr. Abhinav, the senior most direct recruit IAS officer of 2006 batch of Punjab Cadre.

2.3. As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose names have been mentioned at Sl. No. 8 to 18 of the select list of 2010 shall be placed below Dr. Ravi Bhagat, junior most direct recruit IAS officer of 2006 batch and above Ms. Anindita Mitra, the senior most direct recruit IAS officer 2007 batch of Punjab Cadre.

2.4. Seniority /year of allotment of officers at Sl No. 9 to 18 of the select list of 2007 has been restricted under proviso to Rule 3(3) (ii) of IAS (Regulation of Seniority) Rule, 1987.
