2.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose names have been mentioned at Sl. No. 8 to 14 in the Select List of 2016 shall be placed below Shri Krishna Karunesh, junior most RR IAS officer of 2011 batch and above Shri Raveesh Gupta, senior most RR IAS officer of 2012 batch of Uttar Pradesh cadre.

2.3 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose names have been mentioned at Sl. No. 15 to 18 in the Select List of 2016 shall be placed below Shri T.K. Shibu, junior most RR IAS officer of 2012 batch and above Ms. Chandni Singh, senior most RR IAS officer of 2013 batch of Uttar Pradesh cadre.
